Jackie Wilson, Director of the AVA, was our speaker at the meeting. She answered questions from the members and spoke about the general decline in membership in AVA clubs that has occurred in the past few years. Suggestions on ways to interest new potential members and market the AVA to the public were addressed.

TVA Meeting News:

The TVA meeting in Columbus, TX on February 7, 2004 hosted three notable guests: Lyn Clark, IVV Vice President, Shirley Lindberg, AVA President, and John Ferguson, AVA Southwest Regional Director. Plans to hold a sanctioned walk at the National Trails Symposium in Austin on October 21 through 24 were discussed. Arrangements are in the making!

A motion was passed at the meeting to have the TVA sponsor a booth at the National Trails Symposium. If you would like to volunteer to work such a walk or the TVA booth at the Symposium, please contact John Ferguson or Charles Wortz.

A motion was also passed to donate \$1,000 to the AVA general fund and a motion was passed to waive TVA fees for RD sponsored walks in Texas. A motion to change the TVA's New Year's walk from a midnight walk to a New Year 's Day walk failed. A motion to change the dates of the TVA Reunion walks from the first weekend in March to the first weekend in May also failed. As did a motion to rotate the TVA's Memorial/New Year walks among the TVA member clubs.

John Ferguson, AVA Southwest Regional Director addressed the following issues: <u>New Walker Packets</u> – they should contain information about any local clubs. An address questionnaire should be included in the packet which can be filled out upon packet purchase. The club can then follow up to make these new walkers return.

<u>Brochures & Website</u> – Clubs should make their brochures a major sales tool for new walkers and include the *What*, *Where*, *When and How Much*, and information about the AVA as a sales tool for club and event involvement. <u>Waivers</u> – the importance of completing a waiver form at the beginning of each AVA event was stressed. Failure to follow this procedure may negate the liability insurance offered to clubs under the AVA.
