IRS Q&A by Bob

Wright Have a question or comments? Send them to Bob at rcwright_va@adelphia.net how may our club use the money it receives? Simply stated; for your authorized purposes. But that's simplistic, so let's delve deeper. Each club, or state association, has operating expenses and approved purposes. And in the end there will come a time when the club elects to dissolve.

Operating expenses are your administrative expenses-the costs of stamps, stationery, post office box rental, general printing and copying, phone calls, volunteer recognition (e.g., plaques, certificates, refreshments for receptions), services, miscellaneous supplies, etc. that keep your club going day-to-day. These should comprise a small portion of your expenses.

Your principal expenses should be related to your tax-exempt purposes, e.g., Promoting volkssports (e.g., printing educational materials, creating a display about volkssports and your club).

Conducting volkssport events (e.g., event brochures and walk directions, candy and cups for control points, year-round walk box supplies, facility rental, items for making signs). Not sure an expense relates to your purposes? Consult your Articles of Incorporation and Bylaws; then apply common sense, and ask your state association president or regional director if you have questions. What about donations? Before money goes to another organization, think of it this way:

If donating for one of your tax-exempt purposes, could you spend the money yourself without recourse to another organization? If yes, the donation probably is unnecessary. If it is to pool resources, it must be in pursuit of a common purpose with a like-minded 501(c)(3) organization. For example, a donation to the library (almost always a government or 501(c)(3) entity) where you hold meetings would be acceptable.

If the donation were unrelated to any of your tax-exempt purposes, you could not give any organization your money because that would be contrary to why you received tax-exempt status. For example, a donation to an animal rescue organization (probably

a 501(c)(3) itself) would not be appropriate because the AVA and its members don't have a purpose related to animals.

Should time come to dissolve, the IRS gives you greater latitude. Money left over after meeting final expenses may go to any 501(c)(3) organizations and/or the government. (The AVA would be a worthy candidate.) To the end you must ensure donations received for tax-exempt purposes are channeled only to appropriate organizations.

To reach Disney's All Star Sports Resort:

By Air: Register for Disney's Magical Express and be picked up from the airport by the Disney's Magical Express shuttle.

By Train: Take the Amtrak East Coast Express to the Orlando Train Station and then take the Disney Bus to the hotel

By Car: Take the I-4 highway to the Orlando area; watch for the Disney World exits.
