As a public charity, what does my club need to know?

Believe it or not, the IRS considers your club a public charity. The IRS publishes a lot of useful information

on its website at www.irs.gov/charities/index.html.

I recommend you check it out. There is a figure showing the life cycle of a public charity. It expands to discuss your responsibilities regarding annual filings and ongoing compliance. It references the key IRS publications with which your club should be familiar (e.g., 557, Tax-Exempt Status for Your Organization, and 4221-pc, Compliance Guide for 501(c)(3) Public Charities)-if you don't have copies, use the links to download them. The site also links to free online training on topics very pertinent to your operations: maintaining your tax-exempt status, unrelated business income, and disclosures. You will find information on the new e-Postcard should you want to delve into that.

(My recommendation: leave it to Jackie, Candy, and me to keep you posted. The information is still in its formative stage!) Want to keep apprised on issues pertaining to public charities? You may register for the IRS' free on-line EO (exempt organization) newsletter. It's one of my resources for following information of interest to AVA clubs.

The IRS is doing a good job posting pertinent information to its website. Take full advantage; it will steer you straight.
